WHEREAS, by Resolution No. 2011254 the Dutchess County Legislature authorized, empowered and directed the Commissioner of Finance to issue a refund of taxes to the applicant for the 2010 fiscal year in the amount of \$4,059.49 based on a claimed clerical error in the calculation of a Forrest Exemption, and

WHEREAS, the Commissioner of Finance issued a tax refund to the applicant in the amount of \$4,059.49, and

WHEREAS, the applicant appealed claiming the refund was miscalculated and the Court directed that the Forest Exemption be recalculated, and

WHEREAS, the Forest Exemption was recalculated per the Court's Order and it was determined that an additional refund of taxes of \$1,510.23 was due the applicant, and

WHEREAS, there was an error in calculation of the additional refund, and

WHEREAS, the Forest Exemption was recalculated and it was determined that an additional refund of taxes of \$624.27 is due the applicant, and

WHEREAS, a further correction is now necessary, now, therefore, be it

RESOLVED, that Resolution No. 2011254 is hereby amended to correct the sum of taxes to be refunded by the Dutchess County Commissioner of Finance to reflect an additional refund in the amount of \$624.27, and be it further

RESOLVED, that the Dutchess County Commissioner of Finance is authorized empowered and directed to issue a further tax refund to the applicant in the amount of \$624.27 and to charge-back the erroneous taxes on next year's levy as follows:
