RE: AUTHORIZE RECEIPT OF ADDITIONAL FUNDING
(DISTRIBUTION #5) FROM NEW YORK STATE OFFICE OF
INDIGENT LEGAL SERVICES GRANT AND AMENDING THE
2015 ADOPTED COUNTY BUDGET AS IT PERTAINS TO
PUBLIC DEFENDER (A.1170)

Legislators ROMAN, HORTON, WEISS, KELSEY, JETER-JACKSON, MAC
AVERY, FARLEY, and JOHNSON offer the following and move its adoption:

WHEREAS, the Public Defender had advised that the New York State Office of Indigent Legal Services has awarded to the County a grant in the amount of \$471,725 to be used for the continuation of salaries and benefits of staff previously hired under Distribution #2 and the hiring of additional staff, and

WHEREAS, it is now necessary for the Legislature to authorize the receipt of the additional funding (Distribution #5) and amend the 2015 Adopted County Budget to provide for the receipt and expenditure of said funds as outlined in the Grant, now therefore, be it

RESOLVED, that this Legislature hereby authorizes the County Executive to accept the grant award from the New York State Office of Indigent Legal Services and execute the grant agreement and any related documents, and be it further

RESOLVED, that the Commissioner of Finance is hereby authorized, empowered and directed to amend the 2015 Adopted County Budget as follows:
