

## RESOLUTION NO. 2015091

RE: ADOPTION OF NEGATIVE DECLARATION IN CONNECTION WITH THE ESTABLISHMENT OF VARIOUS ZONES OF ASSESSMENT IN THE TOWN OF HYDE PARK

Legislators MICCIO, SAGLIANO, PERKINS, FARLEY, and IGNAFFO offer the following and move its adoption:

WHEREAS, this Legislature has before it a resolution together with maps, plans and reports, all prepared by or on behalf of the Dutchess County Water and Wastewater Authority (“WWA”) in support of the establishment of Zones of Assessment in the County Water District: Arbors Water System – Zone “O”, Violet Avenue Water System – Zone “P”, Greenbush Water System – Zone “Q”, Pinebrook Water System – Zone “R”, Greenfields Water System – Zone “S” and Zone “T”, Quaker Hills Water System – Zone “U”, and the establishment of Pinebrook Sewer System-Part County Sewer District #7 and Greenfields Sewer System – Part County Sewer District #8 by the County of Dutchess (“County”) to facilitate the payment of capital costs through the levy of benefit assessments, and

WHEREAS, as part of its review of the proposed actions the WWA prepared a Short Environmental Assessment Form for each water and sewer, all dated March 18, 2015, and a Negative Declaration for each water and sewer system, all dated March 18, 2015, on file with the Clerk of the Legislature, which conclude that the proposed projects constitute unlisted action pursuant to Part 617 of the New York Code of Rules and Regulations (SEQR), and that the actions will not have a significant effect on the environment, and

WHEREAS, it appears that WWA made a careful review of the proposed actions and this Legislature should confirm those findings, now, therefore, it is hereby

RESOLVED, that this Legislature adopts and confirms the findings of the WWA as set forth in the Short Environmental Assessment Forms and Negative Declarations concluding the proposed actions will not have a significant effect on the environment.

**Acquisition of Hyde Park Water and Sewer Systems  
Adoption of SEQR Determination**

Rudy Viorra offers the following resolution and moves its adoption:

WHEREAS, the Authority proposes to enter into an Agreement with the Town of Hyde Park (Town) regarding the acquisition by the Authority of the following water and sewer systems, currently owned by the Town; Arbors Water System, Violet Avenue Water System, Greenbush Water System, Pinebrook Water System, Greenfields Water System, Quaker Hills Water System, Pinebrook Sewer System and Greenfields Sewer System; and

WHEREAS, upon acquisition of said water and sewer systems, the Authority will continue to provide water service to, and serve the wastewater treatment needs of, the current and future customers of the respective water and sewer systems in accordance with the terms of the Agreements with the Town; and

WHEREAS, the County of Dutchess must create the following Zones of Assessment within the County Water District encompassing the service areas of each respective water system; Zone "O" (Arbors), Zone "P" (Violet Avenue), Zone "Q" (Greenbush), Zone "R" (Pinebrook), Zone "S" and Zone "T" (Greenfields), and Zone "U" (Quaker Hills); and

WHEREAS, the County of Dutchess must execute an Amended and Twelfth Restatement of the Service Agreement with the Authority in order for the Authority to provide water services within this framework; and

WHEREAS, the County of Dutchess must create a Part County Sewer District #7 (Pinebrook Sewer) and a Part County Sewer District #8 (Greenfields Sewer), which District shall be further divided into Zone of Assessment 8-A and Zone of Assessment 8-B, encompassing the service areas of the respective sewer systems; and

WHEREAS, the County of Dutchess must execute a Service Agreement with the Authority on behalf of Part County Sewer District #7, and must execute a Service Agreement with the Authority on behalf of Part County Sewer District #8, in order for the Authority to provide sewer services within this framework; and

WHEREAS, it would be in the public interest for the Authority to acquire the aforementioned water and sewer systems and for the County to establish the Zones of Assessment and Part County Sewer Districts and execute the Service Agreements; and

WHEREAS, in accordance with the requirements of the SEQR, the Authority must make determinations as to the Environmental Impact of these proposed actions; and

WHEREAS, these actions have been classified as "Unlisted" and a Short Environmental Assessment Form has been completed for each water and sewer system the Authority intends to acquire, and these Forms have been submitted to this Board; and

WHEREAS, the service area of each water and sewer system is described in the map and tax parcel list attached to and made a part of each respective Short Environmental Assessment Form, and

NOW, THEREFORE BE IT RESOLVED, that the Authority Board declares itself as Lead Agency for the acquisition of the Arbors Water System, creation of the County Water District Zone of Assessment and execution of the Amended Service Agreement ("the Arbors Water Acquisition"), and

BE IT FURTHER RESOLVED, that the Authority Board does hereby determine that the Arbors Water Acquisition will not have a significant impact on the environment and hereby adopts the attached Negative Declaration with respect to this matter, and

BE IT FURTHER RESOLVED, that the Authority Board declares itself as Lead Agency for the acquisition of the Violet Avenue Water System, creation of the County Water District Zone of Assessment and execution of the Amended Service Agreement ("the Violet Avenue Water Acquisition"), and

BE IT FURTHER RESOLVED, that the Authority Board does hereby determine that the Violet Avenue Water Acquisition will not have a significant impact on the environment and hereby adopts the attached Negative Declaration with respect to this matter, and

BE IT FURTHER RESOLVED, that the Authority Board declares itself as Lead Agency for the acquisition of the Quaker Hills Water System, creation of the County Water District Zone of Assessment and execution of the Amended Service Agreement ("the Quaker Hills Water Acquisition"), and

BE IT FURTHER RESOLVED, that the Authority Board does hereby determine that the Quaker Hills Water Acquisition will not have a significant impact on the environment and hereby adopts the attached Negative Declaration with respect to this matter, and

BE IT FURTHER RESOLVED, that the Authority Board declares itself as Lead Agency for the acquisition of the Pinebrook Sewer System, creation of the Part County Sewer District and execution of the Service Agreement ("the Pinebrook Sewer Acquisition"), and

BE IT FURTHER RESOLVED, that the Authority Board does hereby determine that the Pinebrook Sewer Acquisition will not have a significant impact on the environment and hereby adopts the attached Negative Declaration with respect to this matter, and

BE IT FURTHER RESOLVED, that the Authority Board declares itself as Lead Agency for the acquisition of the Greenfields Sewer System, creation of the Part County Sewer District and two Zones of Assessment and execution of the Service Agreement ("the Greenfields Sewer Acquisition"), and

BE IT FURTHER RESOLVED, that the Authority Board does hereby determine that the Greenfields Sewer Acquisition will not have a significant impact on the environment and hereby adopts the attached Negative Declaration with respect to this matter.
