RE: APPROVING A SERVICE AGREEMENT BY AND BETWEEN  
THE COUNTY OF DUTCHESS AND THE DUTCHESS COUNTY  
WATER AND WASTEWATER AUTHORITY FOR PART COUNTY  
SEWER DISTRICT NO. 8

Legislators MICCIO, SAGLIANO, PERKINS, and IGNAFFO offer the following  
and move its adoption:

WHEREAS, this Legislature has before it a Resolution establishing Part County  
Sewer District No. 8 (Greenfields) in the Town of Hyde Park, and

WHEREAS, in addition, this Legislature, in connection with the establishment of  
Part County Sewer District No. 8, must approve a Service Agreement between Dutchess County  
(County) and the Dutchess County Water and Wastewater Authority (WWA), by the terms of  
which WWA will collect and process the sewerage in the area of the Part County Sewer District  
No. 8, and the County will levy benefit assessments to pay for the capital costs of the sewerage  
system and provide for the enforcement of delinquent sewer bills within the boundaries of the  
Part County Sewer District No. 8, and

WHEREAS, this Legislature, by separate Resolution, has confirmed the findings  
of WWA made the 18th day of March, 2015, that the establishment of Part County Sewer  
District No. 7 will have no significant effect on the environment, and

WHEREAS, the approval of the Service Agreement between the County and  
WWA for Part County Sewer District No. 8 is in the best interests of the citizens of Dutchess  
County, now, therefore, be it

RESOLVED, that the Service Agreement between the Dutchess County and the  
Dutchess County Water and Wastewater Authority is hereby approved and the County Executive  
is authorized to execute said agreement on behalf of the County in substantially the same form as  
on file in the Office of the Clerk of the Legislature.
