WHEREAS, the United States Congress enacted the Workforce Investment Act of 1998 (WIA) to provide the framework for a unique workforce preparation and employment system designed to meet both the needs of businesses and the needs of job seekers and those who want to further their careers, and

WHEREAS, The United States Congress has replaced the WIA with the Workforce Innovation and Opportunity Act (WIOA) and has made provisions for a portion of the WIA funds to be used for transitional planning to WIOA, and

WHEREAS, the New York State Department of Labor has provided allocations to Dutchess County for the operation of PY 2014 Title 1B Adult funding for the period of 07/01/14 through 06/30/16 and for the operation of PY 2014 Title 1B Dislocated Worker funding for the period of 07/01/14 through 06/30/16 and for the operation of PY 2014 Title 1B Administration funding for the period of 07/01/14 through 06/30/16 and for the operation of PY 2014 Title 1B WIOA Transition funding for the period of 07/01/14 through 06/30/16, now, therefore be it

RESOLVED, that the Commissioner of Finance be and hereby is authorized, empowered and directed to accept the allocation of funding under the above WIA Programs and amend the following accounts:
