RE: AUTHORIZING AMENDMENT OF FUNDING UNDER THE TRADE ADJUSTMENT ASSISTANCE ACT AND THE WORKFORCE INNOVATION & OPPORTUNITY ACT

WHEREAS, the United States Congress enacted the Trade Adjustment Assistance (TAA) Program and Workforce Innovation and Opportunity Act of 2014 (WIOA) to provide the framework for a unique workforce preparation and employment system designed to meet both the needs of businesses and the needs of job seekers and those who want to further their careers, and

WHEREAS, the New York State Department of Labor has provided allocations to Dutchess County for the operation of:

- * FY 2014 TAA funding for the period October 1, 2013, through September 30, 2016;
- * PY 2015 Title 1B WIOA Adult funding for the period of July 1, 2015 through June 30, 2017;
- * PY 2015 Title 1B WIOA Dislocated Worker funding for the period of July 1, 2015 through June 30, 2017; and
- * PY 2015 Title 1B WIOA Administration funding for the period of July 1, 2015 through June 30, 2017, and

WHEREAS, the New York State Department of Labor has reduced Dutchess County's funding for the operation FY 2013 TAA funding for the period of October 1, 2012, through September 30, 2015, now, therefore be it
