Legislators FORMAN, MICCIO, BOLNER, FLESLAND, PULVER, SAGLIANO, and WASHBURN offer the following and move its adoption:

WHEREAS, in accordance with New York State Agricultural and Markets Law Section 303-a and the recommendations of the Dutchess County Agricultural and Farmland Protection Board, the Legislature is considering the recertification of Agricultural District No 21, which includes the Towns of Pine Plains, North East, Amenia, Stanford, Washington and the Villages of Millerton and Millbrook, and

WHEREAS, the Legislature has before it a report and recommendations with respect thereto from the Dutchess County Agricultural and Farmland Protection Board which recommended minor changes to Agricultural District No. 21 as presently constituted, and

WHEREAS, a public hearing is required as part of this review process, now, therefore, be it

RESOLVED, that this legislature shall hold a public hearing on the 11<sup>th</sup> day of April, 2016, in the Dutchess County Legislative Chambers at 7pm to review Agricultural District No. 21 to determine if it should continue, modify or terminate such district and, be it, further

RESOLVED, that the Clerk of the Legislature is instructed to give public notice of such hearing in accord with the provisions of the Agriculture and Markets Law Article 25-AA.
