RE: AUTHORIZING AMENDMENT OF FUNDING UNDER THE TRADE ADJUSTMENT ASSISTANCE ACT AND THE WORKFORCE INNOVATION & OPPORTUNITY ACT

Legislators THOMES, BOLNER, STRAWINSKI, SAGLIANO, HORTON, TRUITT, and JETER-JACKSON offer the following and move its adoption:

WHEREAS, the United States Congress enacted the Trade Adjustment Assistance (TAA) Program and Workforce Innovation and Opportunity Act of 2014 (WIOA) to provide the framework for a unique workforce preparation and employment system designed to meet the needs of businesses and the needs of job seekers and those who want to further their careers, and

WHEREAS, the New York State Department of Labor has provided allocations to Dutchess County for the operation of:

- * FY 2014 TAA funding for the period October 1, 2013, through September 30, 2016;
- * PY 2015 Title 1B WIOA Adult funding for the period of July 1, 2015 through June 30, 2017;
- * PY 2015 Title 1B WIOA Dislocated Worker funding for the period of July 1, 2015 through June 30, 2017; and
- * PY 2015 Title 1B WIOA Admin funding for the period of July 1, 2015 through June 30, 2017, now, therefore be it

RESOLVED, that the Commissioner of Finance be and hereby is authorized, empowered and directed to accept the allocation of funding under the above TAA and WIOA Programs and amend the following accounts:
