WHEREAS, the National Association of County and City Health Officials (NACCHO) has awarded the County an award entitled the Medical Reserve Corps (MRC) Challenge Award in the sum of \$15,000 to support important emergency and health preparedness initiatives, and

WHEREAS, it is necessary for this Legislature to authorize the execution of the grant agreement and to amend the 2016 Adopted County Budget to accept such funds and provide for the receipt and expenditure of said funds, now therefore, be it

RESOLVED, that this Legislature hereby authorizes the County Executive, or his designee, to accept the award funds from NACCHO in connection with the above and further authorizes and empowers the County Executive or his designee to execute said award contract and any amendments on behalf of the County of Dutchess, and be it further

RESOLVED, that the Commissioner of Finance is hereby authorized, empowered and directed to amend the 2016 Adopted County Budget as follows:
