WHEREAS, the United States Congress enacted the Trade Adjustment Assistance (TAA) Program and the Workforce Innovation and Opportunity Act (WIOA) to provide the framework for a unique workforce preparation and employment system designed to meet the needs of businesses and the needs of job seekers and those who want to further their careers, and

WHEREAS, the New York State Department of Labor has provided allocations to Dutchess County for the operation of

- * FY 2015 TAA for the period of October 1, 2014 through September 30, 2017;
- * PY 2016 Title 1B WIOA Admin funding for the period of July 1, 2016 through June 30, 2018;
- * PY 2016 Title 1B WIOA Adult funding for the period of July 1, 2016 through June 30, 2018;
- * PY 2016 Title 1B WIOA Dislocated Worker funding for the period of July 1, 2016 through June 30, 2018; now, therefore be it
