## Public Comment Period

### Community Development Block Grant & HOME Program

Dutchess County has developed its draft 2015 Consolidated Plan Annual Action Plan. This Plan is based upon the 2013-2017 Consolidated Plan which is required for receipt of funds from U.S. Dept. of Housing and Urban Development's (HUD) Community Development Block Grant (CDBG) and HOME Investment Partnership (HOME) programs.
