RE: AUTHORIZING AMENDMENT OF FUNDING
UNDER THE TRADE ADJUSTMENT ACT

Legislators GARITO, TRUITT, HOUSTON, POLASEK, MC HOUL, D'AQUANNI, FAUST, VERSACI, and GORMAN offer the following and move its adoption:

WHEREAS, the United States Congress enacted the Workforce Innovation and Opportunity Act (WIOA) to provide the framework for a unique workforce preparation and employment system designed to meet the needs of businesses and the needs of job seekers and those who want to further their careers, and

WHEREAS, the New York State Department of Labor has recently provided Notices of Obligational Authority (NOA) which set forth the allocations to Dutchess County for the operation of:

- PY 24 ADULT for the period of 7/1/2024 through 6/30/2026; and
- PY 24 DISLOCATED WORKER for the period of 7/1/2024 through 6/30/2026; and
- PY 24 ADMINISTRATION for the period of 7/1/2024 through 6/30/2026;

WHEREAS, PY24 ADULT and PY24 DISLOCATED WORKER and PY24 ADMINISTRATION are NOAs, thereby allowing an extension of the term only, without a separate resolution, now therefore be it

RESOLVED, that the Commissioner of Finance be and hereby is authorized, empowered and directed to accept the allocation of funding under the above Workforce Innovation Opportunity Act (WIOA) Program and amend the following accounts:

Please find attached a Resolution Request form and Fiscal Impact Statement for a resolution to be presented at the next available Meeting of the County.

The DCWIB receives Notices of Authority (NOA) from the New York State Department of Labor (NYSDOL) to provide training and employment services to adults, dislocated workers and youth who reside in Dutchess County. NOA's either supply additional funding or rescind expired funding. The attached NOA is supplying additional funding to Dutchess County.

This NOA represents our final round of WIOA funding for adult and dislocated workers and the accompanying administrative funding for PY24
NOA- \$776,718.76

Note-The DCWIB expects to receive an additional NOA for the renewable energy grant funding that we applied for last month, “any day”. This program called “RETI” started 8/1/24 and runs until 7/31/2025. We fully expect that date to be extended as we have yet to receive the NOA for the funding. We respectfully request a “space holder”, in the December meeting, for this grant funding which will bring \$250,000 into Dutchess County to train people in renewable energy jobs.
