Minutes of a Joint Annual Meeting of the Sole Member
and the Board of Directors
March 22, 2024

A joint annual meeting of the Sole Member and the Board of Directors (the "Board") of Dutchess Tobacco Asset Securitization Corporation (the "Corporation"), a local development corporation organized pursuant to Section 1411 of the Not-for-Profit Corporation Law of the State of New York, was duly called to order at 11:32am at 22 Market Street, Poughkeepsie, New York.

RECEIPT OF COMMITTEE REPORTS:

The Board received the report of Audit Committee from the Committee Chair in the form of minutes of the March 2023, committee meeting.

The Board received the report of the Governance Committee from Committee Chair in the form of minutes of the March 2023, committee meeting.

APPROVAL OF FINANCIAL REPORT FOR 2023:

The financial statements of the Corporation for the fiscal year ended December 31, 2023, audited by Drescher & Malecki, and approved by the Audit Committee were presented to the meeting and reviewed by the Sole Member and the Board of Directors.

The Sole Member introduced for adoption by the Board, and the Board approved the adoption of the following resolution:

RESOLVED, that the financial statements for the fiscal year ended December 31, 2023, as present to the meeting, are accepted by the Sole Member as the Annual Report of Directors under Section 519 of the Not-for-Profit Corporation Law.

RESOLVED, that the directors and officers of the Corporation be, and the same hereby are, authorized, empowered and directed to do all things and acts and to execute all documents as may be necessary or advisable and properly carry on the business of the Corporation.

RESOLVED, that *Michael Betros, James Fedorchak, Charles Traver* are appointed as members of the audit, finance and governance committees, all until their respective successors are appointed or until their earlier resignations.

APPROVAL TO FILE PARIS REPORTS:

Treasurer Seelbach requested authorization to prepare and file PARIS reports required to be filed by the Corporation at the end of the month. After discussion, on motion duly made and seconded, Treasurer Seelbach was authorized and directed to prepare and file the reports. Treasurer Seelbach sent draft PARIS report. The Reports are substantially the same as last year and are available on the website, and the Budget Report is also on the website. The 2024 Budget also included and anticipated to be very similar to 2023. No change to the governance procurement.

APPROVAL OF 2024 BUDGET:

Treasurer Seelbach presented to the Board a proposed budget for 2024, noting that the Board may not be meeting in the ordinary course of events again prior to the 2024 annual meeting, absent a decision to proceed with a refinancing. She also said that, absent such a refinancing, the operations of the Corporation were sufficiently similar year to year to allow her to prepare a budget at this time. In the event of a refinancing, the Corporation could review its budget at that time for any required changes.

After review and discussion, on motion duly made and seconded, the 2024 budget was approved.
