EXTENSION OF DECLARATION OF LOCAL EMERGENCY ORDERS #2, #10 AND #11

EMERGENCY EXECUTIVE ORDER NO. 2 of 2020

WHEREAS, a State of Emergency was hereby declared in the County of Dutchess effective on March 13, 2020, by Emergency Executive Order No. 2 of 2020 due to a case of COVID-19 being confirmed in the County,

WHEREAS, on March 13, 2020, Local Emergency Order #2 was declared pursuant to § 24 of the New York State Executive Law ordering:

LOCAL EMERGENCY ORDERS:

• Local Emergency #2, Section 1. Regulation of Public Gatherings:

All social, community, and public events or gatherings, including Dutchess County sponsored events, where it is anticipated that attendance will exceed twenty (20) people or more, shall be restricted, cancelled or postponed.

• Local Emergency # 10, Section 1, Public Transit:

Dutchess County Division of Public Transit (Public Transit) shall suspend its customary fare requirements for bus service in Dutchess County. While individuals should continue to limit their use of public transportation to when it is absolutely necessary and should limit potential exposure by practicing social distancing of at least 6 feet between persons, Public Transit shall reduce its fares for the general public on all fixed routes and shall provide same-day, on-demand service. Fixed route fares are hereby reduced to a rate of zero cents (\$0.00) per ride. The fare for same-day, on-demand service will be zero dollars (\$0.00).

• Local Emergency Order #11, Tax Foreclosure:

Notwithstanding that the Petition and Notice of Foreclosure for Dutchess County's 2020 in

rem tax foreclosure action set a redemption date of May 29, 2020 as permitted by Real

Property Tax Law 1110(2), any obligation to either redeem unpaid taxes or to file an

Answer in such action pursuant to Article 11 of the Real Property Tax Law is hereby

stayed.

SECTION 2. PUNISHMENT:

Failure to obey this order is a criminal offense, punishable by law under New York State

Executive Law § 24(5). In accordance with Executive Law Section 24(5), any person who

knowingly violates the provisions of this order shall be guilty of a Class B Misdemeanor.

SECTION 3. EFFECTIVE:

I, Marcus J. Molinaro, the County Executive of Dutchess County, in accordance with a

declaration of a State of Emergency issued on March 13, 2020, and pursuant to § 24(2) of the

New York State Executive Law, do hereby order that the above local emergency order be

extended from May 17, 2020 at 12am through May 21, 2020 at 11:59pm.

SECTION 4. DURATION.

This Order shall remain in effect until removed by the order of the County Executive and

may also be renewed in five (5) day increments.
