Legislator Drago asked what the law is regarding the current body's authority to confirm appointments that will begin on January 1, 2026, given that the legislature will have a new makeup at that time.

Majority Leader Houston requested a five-minute caucus.

Committee Chair D'Aquanni entertained a motion to reconvene the Environment Committee. Motion carried.

Legislative Counsel Lindars stated "I've had a moment to speak with Miss Blackburn and it's our opinion that each of these appointments are either for a three or five year term, and all of these boards serve on staggered terms. Therefore, the constitution of those boards inherently binds a future board, but each board has the ability to do so. There isn't any prohibition from us doing it. The board can do it now because the same rule would apply to you guys coming in and the next board you'd have you'd be prohibited under the under your reasoning, and you can't do that, government would stop functioning. Because the terms are three or five, they exceed the term of the legislatures and they're staggered terms. For those reasons it's permissible."
