

# The Projected Impact of Bail Reform in Dutchess County

# MISDEMEANORS

Money bail is eliminated with only two exceptions:

- ❖ Sex Offenses; and
- ❖ Criminal Contempt charges for an Order of Protection violation in a domestic violence case.

Straight pre-trial detention (remand) is eliminated in all misdemeanor cases.

# NON VIOLENT FELONIES

Both money bail and pre-trial detention are eliminated in virtually all non violent felonies with the following exceptions:

- ❖ Witness Intimidation or Tampering;
- ❖ Conspiracy to Commit Murder;
- ❖ Felony Criminal Contempt charges involving DV (Criminal Contempt 1<sup>st</sup> & Aggravated Criminal Contempt); and
- ❖ a limited number of offenses against children, sex offenses and terrorism-related charges.

# VIOLENT FELONIES

Money bail and detention are still permitted in virtually all violent felonies except specific subsections of Burglary 2<sup>nd</sup> and Robbery 2<sup>nd</sup>.

Bail and detention are also permitted in cases classified as Class A Felonies, most of which also involve violence.

A notable caveat: bail and detention are eliminated for all Class A drug felonies, with the sole exception of operating as a major trafficker.


# RELEASE UNDER NON-MONETARY CONDITIONS

If a principal is released under non-monetary conditions, the Court shall, on the record:

- ❖ provide an individualized written document in clear and specific language as to the conditions the principal is subject; and
- ❖ Notify the principal of the possible consequences for violation of a release condition, including revocation and the ordering of a more restrictive order.


In addition, the court must provide notification, or direct a certified PTR agency to notify the principal under non-monetary conditions AND principals under ROR, of all court appearances in advance by text message, telephone call, email, or first class mail.

### ALL DCJ Admissions 2016 - 2018




# Admittances Bailable vs. Non-Bailable by Crime Type (2016 - 2018)



% DCJ Admittances - Bailable vs Non-Bailable by Crime Type - 2016 - 2019 (proj.)




Actual DCJ Admittances - 2016 - 2019 (proj.) Without Bail Reform vs. Bail Reform

# System Response to Non-Bailable Offenders who are Convicted of a Crime??

## Length of Stay - Correlation with Rate of Conviction for DCJ Inmates



Given current efforts of the CJC to ensure efficient use of DCJ bed days and other alternatives to best enhance public safety, it is significant to understand the impact of these groups on DCJ bed days. As depicted below, analysis revealed that people who were incarcerated for 30+ days during the study period (January 2013 - January 2019) represented 42.4% of all releases; yet utilized 93.5% of all jail days.


Therefore, combining the current results with those of the previous 100+ day study, it can be inferred with a reasonable degree of statistical certainty, that **98.4% people who were released after serving 30 days or more in the Dutchess County Jail were convicted of some crime and sentenced either locally or to State Prison or incarcerated as a result of or related to a parole or probation violation. This group also consumed 92% of total jail days used from January 2013 – January 2019.**


% Released to Prison and to Street -

Percentage Proxy Risk (Non-Bailable Offenses) - Prison vs. Street Release by # Jail Days Served (1-29 vs. 30+)





# Projections – 2020 Jail Population Based Upon Current Jail Population of 350

- What we know by ALL DCJ Releases from Jan. 2016 – April 15, 2019 (N=8813 releases consumed 420,492 jail days):
  - Bailable Offenses Consumed 27.5% of All Jail Days (N=2138 releases accrued 115,668 jail days)
  - Non-Bailable Offenses Consumed 72.5% of All Jail Days (N=6675 releases accrued 304,824 jail days)
    - 37% of Releases Incarcerated on Non-Bailable Offenses Spent 30+ Days in the DCJ
    - 30+ Day Releases consumed 91.7% of Non-Bailable Jail Days (N=2470 releases accrued 279,451 jail days)
    - 98.4% of 30+ Day Releases were convicted and sentenced or incarcerated due to a parole or probation violation

## 30+ Day Releases – Non-Bailable (91.7% of All Non-Bailable Jail Days) (N=2470 Releases)

- What we know by ALL Non-Bailable 30+ Day Releases (Jan. 2016 – April 15, 2019):
  - 1882 were released to the street (No Parole Detainer) with an ALOS of 102.2 Days (N=192,359 jail days)
  - 153 with a Parole Detainer were released to the street with an ALOS of 149.8 Days (N=22,914 jail days)
  - 435 were released to Prison with an ALOS of 147.5 Days (N=64,178 jail days)

# Assumptions made to obtain a Projection for 2020 Jail Population Based Upon Current Jail Population of 350

- The # of Jail Days used by people charged with Bailable Offenses will remain constant.
- The # of Jail Days used by people charged with Non-Bailable Offenses who prior to 1/1/20 served 30+ Jail Days will be reduced as follows:
  - ALOS of 102.2 Days for people released to the street with no Parole Detainer (69% of 30+ Day Releases) could be reduced by up to 30 Days to 72.2 Days.
  - ALOS of 149.8 Days for people with a Parole Detainer released to the street (8% of 30+ Day Releases) could be reduced by up to 60 days to 89.8 Days.
  - ALOS of 147.5 Days for people released to Prison (23% of 30+ Day Releases) could be reduced to an ALOS of 30-60 days.
- The # of Jail Days used by people charged with Non-Bailable Offenses who prior to 1/1/20 served 1-29 Jail Days (63% of all Non-Bailable Releases) will be reduced as follows:
  - ALOS will remain constant for at least 10.1% of releases who were sentenced to the DCJ or who had a Parole Detainer lodged.
  - 89.9% will not serve jail time pending adjudication and a significant percentage of this group will not serve any jail time.
