Event Guidelines

Dates: Saturday & Sunday December 5-6, 2020

Event time: 6:00PM - 9:00PM

Check in & set up: December 5 begins 1:00PM (Display to remain in place overnight. You must be fully set up by 5:00PM)

Location: Wilcox Memorial Park Rt 199 Stanfordville, NY

Registration: FREE

Holiday displays will be financed by each participating organization.

Any organization that wishes to enter a display in the **Dutchess County Parks** *Go Light Your World* **Holiday Illumination Weekend** must file a display theme and design with the park lead for approval. Display entries can not be obscene or derogatory in nature. A full description of the display must accompany the application and no party-political displays allowed. All displays are subject to a safety inspection by an event committee member. Each participating organization must check in upon arrival at Wilcox before proceeding to their designated space in the park to begin set up. The displays must be structurally sound and well anchored so that there is no risk of collapse or blown obstacles. Each display must always have a volunteer lead to oversee their space and ensure the electric and exhibition is safe. The volunteer lead will also oversee others within their area and ensure they do no not enter the moving traffic. All displays must be set up/taken down by individual organizations. In addition, Dutchess County Parks requests the following:

- Sign and return contract accepting event policies and hold harmless agreement (The signature is on behalf of all participants in the group)
- Insurance for each organization (see insurance requirements)
- Estimated number of attendees per site Maximum number of people is 10. Ages 7+
- Generator, extra fuel and a working fire extinguisher to support their display
- No candy or objects to be thrown. Nothing should be handed out to passing vehicles
- No weapons (fake or real) or open flames
- No animals unless approved prior by Dutchess County Parks
- No alcoholic beverages during the event
- All entries must be holiday themed Dutchess County Parks has the right to remove the entry that does not conform to the event rules and regulations
- No amplified music. There will be an event radio frequency for holiday music
- Photo & video permission from each participating entity

Each display can remain in place overnight as the park will be supervised.
