Subordination Request Form**

Processing a subordination takes approximately 2 weeks. The process can be slightly longer in the summer, holidays and budget time (last two weeks in October). Persons wanting subordinations must have the bank/mortgage agency complete the following information and e-mail to asaylor@dutchessny.gov.

The County will prepare and process the subordination. The County measures the 2 weeks from the receipt of this information. The 2 week processing timeframe also assumes usage of the County's standard subordination agreement (attached for your review). Other subordination agreements will take longer as the County Attorney must review and approve such documents.
