² Two (2) highest elected officials from the thirteen (13) non-urban Towns (Amenia, Clinton, Dover, Milan, North East, Pawling, Pine Plains, Pleasant Valley, Red Hook, Rhinebeck, Stanford, Union Vale, and Washington) and six (6) non-urban Villages (Millbrook, Millerton, Pawling, Red Hook, Rhinebeck, and Tivoli). These members shall be appointed by the Dutchess County Supervisors and Mayors Association for two-year terms starting on January 1st of the year of appointment through December 31st of the last year of appointment.
