**Call us to schedule a Closing.**

Please allow *five business days* to arrange for a closing bill when you sell your home or property since a last water meter reading is required. Only the current homeowner can call to schedule the closing meter reading and close the account. A realtor or future home buyer cannot request this. To request a closing bill, call (845) 486-3601.



**PUBLIC HEARING ON YEARLY RATES:**

**COLLECTION THROUGH TAX BILLS**
