Meeting Open – Introductions

Capital Project Reports

**GFW & HPR EFC Funding Application – Memo**

The Greenfields Water System obtains its water supply from groundwater using four wells. In 2020, NYS set maximum contaminant levels (MCLs) of 10 parts per trillion each for perfluorooctanoic acid (PFOA) and perfluorooctanesulfonic acid

(PFOS), and part per billion for 1,4-dioxane. Required testing since then has revealed that the GFW is out of compliance for PFOAS/PFOS and have been directed by Dutchess County Behavioral & Community Health to provide a remedy. We are pursuing an E.F.C. grant (WIIA grant) to help resolve the PFAS/PFOS issues at the Greenfield Water System. Part of the requirement of the grant package is that a board resolution is required authorizing required funding. H2M is preparing the required engineering report which will include the construction estimate expected to be in the neighborhood of 15 million including:

- Connection to the Greenfields Water System from the Hyde Park Water System.
- Improvements to the Hyde Park Water Treatment plant to accommodate the additional service load.

Authority staff have conducted the necessary SEQRA process as Lead Agency. The grant application requires the following resolutions to be approved by the DCWWA Board:

- Resolution for authorization for borrowing and bond
- Resolution for authorization to submit grant
- Resolution for SEQR Negative Declaration

In order to provide a remedy to the GFW water supply, the funding we are pursuing is necessary and we recommend approving these resolutions.

Larry Knapp made a motion to Authorize the Authority's E. F. C. Service Agreement Revenue Obligations – 2022 (Greenfields Water System) and the Approval and Execution of Related Documents. This was seconded by Dale Borchert, a roll call vote was taken, and the resolution passed unanimously. **(Res.2022.09.AA)**.
