

STATE OF EMERGENCY DECLARATION

A State of Emergency is hereby declared in Dutchess County, New York effective immediately.

This State of Emergency has been declared due to the impacts of the remnants of Hurricane Ida, which have compromised public safety.

The State of Emergency will remain in effect for thirty (30) days or until rescinded by a subsequent order.

As the Chief Executive of the County of Dutchess, I, Marcus J. Molinaro, exercise the authority given to me under Section 24 of the New York State Executive Law, to preserve the public safety and herby render all required and available assistance vital to the security, well-being, and health of the citizens of Dutchess County.

I hereby direct all departments and agencies of Dutchess County to take whatever steps necessary to protect life and property, public infrastructure, and provide such emergency assistance deemed necessary.

EMERGENCY ORDER

Local Emergency Order for Dutchess County, New York, to include the following municipalities:

I, Marcus J. Molinaro, the Chief Executive if Dutchess County, in accordance with a declaration of a State of Emergency issued on September 2, 2021, and pursuant to Section 24 of the New York State Executive Law, do hereby order:

- ALL NON-ESSENTIAL TRAVEL IS RESTRICTED ON PUBLIC ROADWAYS IN THE ABOVE NAMED MUNICIPALITIES UNTIL 9AM THIS DATE.
- ALL COUNTY OFFICES SHALL OPEN AT 10AM THIS DATE.

This order shall take effect immediately and shall remain in effect for five (5) days unless rescinded earlier by order of the Chief Executive. This order may also be renewed in five (5) day increments.

Failure to obey this order is a criminal offense, punishable by law under New York State Executive Law Section 24(5).
