2024125 ADOPTION OF ENVIRONMENTAL ASSESSMENT FORMS AND DECLARATION OF SIGNIFICANCE FOR THE DUTCHESS COUNTY CONSOLIDATED TWO-WAY RADIO COMMUNICATION SYSTEM PROJECT

Majority Leader Houston moved the foregoing resolution, duly seconded by Assistant Majority Leader Polasek. Discussion on resolution No. 2024125 proceeded as follows:

Legislator Kaul questioned Commissioner Smith regarding, Harmony Hill in Holmes and 25 Highland Street in Millerton, which were listed as housing endangered species. She asked if someone could speak to the measures that were taken to mitigate harm. Assistant County Executive Baiano's response attached hereto.

Commissioner Smith stated the sites were existing structures and would follow up with her. Legislator Kaul then questioned the proposed site at College Hill. Stating that the answer to Question Number 12 was incorrect.

Commissioner Smith answered that he would work with the consultant and make sure it was appropriate.

Assistant Minority Leader Atkins questioned Legislative Counsel Lindars what could happen being that the document indicated "no" twice and then later it was found that it was a historic site?

Legislative Counsel Lindars replied there would have been an environmental review done within the county. Generally, if there was an error on the SEQRA review, it would be required to either have an amendment or leave the action challengeable under a faulty SEQRA.

Legislator Kaul asked if finding a faulty SEQRA would further delay this project?

Legislative Counsel Lindars responded that if they could do the amendment, it would not, but if somebody challenged the entire project to stop the project, then this would be an avenue by which you could challenge the determination. He added The Part 1's were generally created off an EAF Mapper from the DEC website. He further stated the information generated on them was from the DEC and self-generated.

At this time, Chair D'Aquanni entertained a motion from the floor, which was seconded and carried, for a Republican Caucus.

Radio Tower site question

Good evening,

Legislator Kaul posed a question during the Environmental Committee regarding the area of two tower sites, Harmony Hill in Holmes and 25 Highland Street in Millerton, which were listed as being in an area that housed endangered species, and asked what measures will be taken to mitigate any potential harm.

The two subject sites in question have an existing radio tower structures that will be used to support the antennas eliminating the need to erect a new tower and therefore there will not be a need for ground disturbance to erect a tower. Likewise, the radio equipment will be placed in an existing building so excavation and foundation construction are not required. A generator and associated fuel tank will be installed, however these will both be placed in the developed and open area of the facility which will greatly minimize the need for ground disturbances.
